

| <p><b>Question No. 2:</b></p> <p>Should the bidder/s quote for all items under the lot it/they will bid for?</p>                                    | <p><b>Answer No. 2:</b></p> <p>Yes, bidder/s who is/are interested to bid should include all items under each lot it/they will bid/s for.</p>  |
| <p><b>Question No. 3:</b></p> <p>Where to submit the bid documents? Is it possible to submit it to the SEC Extension Office or through courier?</p> | <p><b>Answer No. 3:</b></p> <p>Bids should be received by the BAC through its Secretariat in the location specified in the Bidding Documents, specifically in the Invitation to Bid:</p> <p><b>"8. Bids must be duly received by the BAC Secretariat through manual submission at the Procurement Division, 7<sup>th</sup> Flr, The SEC Headquarters, 7907 Makati Avenue, Salcedo Village, Bel-Air, Makati City on or before June 16, 2023 (Friday) 9:00 A.M. Late bids shall not be accepted.</b></p> <p>Sending through courier is allowed. However, bidder/s should ascertain that bids would be received by the BAC on or before the deadline.</p> |
