**DECLARATION OF LOWEST CALCULATED AND RESPONSIVE QUOTATION AND  
RECOMMENDING AWARD OF CONTRACT**

(Resolution No. 2024-071)

**WHEREAS**, Purchase Request No. 202403127 (Annex A) was received on 19 March 2024 for the **SUPPLY AND DELIVERY MEALS FOR SEC SEMINAR IN GENERAL SANTOS CITY** with approved budget for the contract in the amount of **TWO HUNDRED THIRTEEN THOUSAND FIVE HUNDRED EIGHTY-THREE PESOS AND 33/100 (Php 213,583.33)**;

**WHEREAS**, Request for Quotation No. AMP 2024-035 was posted in PhilGEPS on 02 April 2024 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

**WHEREAS**, in compliance with Republic Act No. 9184 and its implementing rules and regulations, the Bids and Awards Committee Secretariat, on 02 April 2024, invited (Annex C is proof) the legally, technically, and financially capable suppliers;

**WHEREAS**, on or before the deadline to submit quotations - i.e., 24 January 2024, 10AM - the following quotations were received and opened (Annex D is Abstract of Quotation):

**WHEREAS**, after verification and validation of all accepted proposals on 17 April 2024 (Annex E is Evaluation Report), it was determined that the quotation of **CHEF GARLY'S MERYENDA EXPRESS AND SIZZLERS** in the amount of **ONE HUNDRED SIXTY THOUSAND PESOS (P160,000.00)** is the lowest calculated and responsive quotation for the subject procurement.


