- Request to relax the requirement on Document Size
- Minimum: 48 x 50mm (1.9 x 2 in)
 Maximum:215.9 x 355.6 mm (8.5 x 14 in.)
 Long Range Scanning: up to 6,096mm (240 in.)

- Request to relax the requirement on having Ethernet or Wi-Fi connections
- Interface: Ethernet 10BASE-T, 100BASE-TX, 1000BASE-T

- Retain the requirement
- The Commission will get scanners that can handle document ranging from small receipt (1.9 x 2 in.) to legal/long documents (8.5 x 14 in.), accommodating various business needs

As to long range scanning, the required size is beneficial for scanning items like continuous forms, contracts, and any other long-page documents. This feature will be helpful to digitize unusually long documents.

- Retain the requirement
- Ethernet connections are known for their stability and reliability. Using a wired connection ensures a consistent and uninterrupted data transfer between the scanner and the network. This is crucial for offices that require reliable scanning operations without the potential interference or signal fluctuations associated with wireless connections. The bidder may offer scanners with Ethernet and Wi-Fi capabilities.

Request to include the following certifications:

- Certification from the manufacturer that the bidder is an Authorized Reseller/Distributor of the brand to be offered.
- 2. Certificate of Authorized Service Provider issued by the manufacturer.
- 3. Certificate of Product Authenticity and the machine to be delivered is brand new issued by the manufacturer.

No certification required
