

AGREEMENT


THIS AGREEMENT made the ____ day of May 2024 between the **SECURITIES AND EXCHANGE COMMISSION** (hereinafter called "the Entity"), with office address at the SEC Headquarters, Makati Avenue, Salcedo Village, Bel-air, Makati City, represented by the Authorized Representative of the Head of the Procuring Entity, EDHONA C. TANTUAN, of the one part, and **R. CARAM MULTIMEDIA CORP. (ISLAND LIVING CHANNEL)**, with office address at 722 Metropolis Tower, Lacson St., Brgy. Mandalagan, Bacolod City, Negros Occidental, Philippines, represented by its President and Chairman, RADJIE E. CARAM JR., (hereinafter called "the Service Provider") of the other part;

WHEREAS, the Entity required the advertising placement on various airports and seaports, particularly **PLACEMENT OF OUT-OF-HOME ADS FOR INVESTOR EDUCATION AND OTHER INFORMATION CAMPAIGNS ON ISLAND LIVING CHANNEL**, and has accepted the proposal by the Service Provider for the services in the sum of **SIX MILLION PESOS (P6,000,000.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - (a) Terms of Reference;
 - (b) Request for Quotation;
 - (c) Winning bidders' proposal, including the Eligibility requirements, documents and/or statements submitted;
 - (d) Notice of Award of Contract and the winning bidders *conforme* thereto; and
 - (e) Other contract documents that may be required by existing laws and/or the Entity
3. In consideration for the sum of the Contract Price or such other sums as may be ascertained, the Bidder agrees to provide the Project in accordance with his/her/its Quotation.
4. The Entity agrees to pay the above-mentioned sum in accordance with the terms of the Quotation.


