WHEREAS, Purchase Request No. 202404311 (Annex A) was received on 24 April 2024 for the **Supply and Delivery of Glass Accessories** with approved budget for the contract in the amount of **Forty-Nine Thousand Six Hundred Fifty Pesos (Php49,650.00)**;

WHEREAS, Request for Quotation No. 2024-049 was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on 26 April 2024 for the abovementioned procurement;



WHEREAS, after verification and validation of the proposal on 03 May 2024 (Annex D is Evaluation Report), it was determined that the quotation of **NS23 General Merchandise** in the amount of **Forty-Nine Thousand Six Hundred Fifty Pesos (P49,650.00)** is the single calculated and responsive quotation for the subject procurement.


