The Securities and Exchange Commission (SEC) issues this advisory in response to numerous inquiries, reports, and information received regarding the activities of individuals or groups representing an entity named **NEW WORLD AI**. It has come to our attention that this entity is soliciting investments from the public, promising significant monetary rewards or profits.

Based on reports from concerned individuals and observations made on social media platforms, **NEW WORLD AI** is inviting the public to invest in its offerings, categorized as Investment Product Packages, through its website <https://nwaitech.com/m/index>. These packages promise returns as high as 1,185% interest income, which raises concerns about the legitimacy of the investment schemes.

Based on the Commission's records, **NEW WORLD AI** is neither registered as a corporation or partnership nor has it obtained prior registration and/or license to solicit investments as mandated by Section 8 and 28 of the Securities Regulation Code.

Furthermore, the business model employed by **NEW WORLD AI** exhibits characteristics of a "possible Ponzi scheme" where funds from new investors are utilized to pay "fake profits" to earlier investors. This structure predominantly benefits top recruiters and initial risk-takers at the expense of subsequent members if the influx of new investors declines.

Additionally, Republic Act No. 11765, or the Financial Products and Services Consumer Protection Act (FCPA), explicitly prohibits investment fraud, which includes Ponzi schemes and other similar schemes that promise or offer profits or returns derived from the investments or contributions made by the investors themselves, as well as the offering or selling of investment schemes without a license or permit from the SEC.

The SEC strongly advises the public to exercise utmost caution when engaging with entities such as **NEW WORLD AI**. Investment schemes offering high returns with seemingly low risks should be carefully scrutinized. Investors are encouraged to perform due diligence, validate the legitimacy of investment opportunities, and review the associated terms and conditions.

Individuals acting as salespersons, brokers, dealers, agents, promoters, recruiters, uplines, influencers, endorsers, abettors, or enablers of **NEW WORLD AI** may face criminal liability under Section 11 of the FCPA and Section 28 of the SRC, punishable by a maximum fine of Five Million Pesos (Php 5,000,000.00) or imprisonment of Twenty-One (21) years, or both, as stipulated in Section 73 of the SRC (SEC Vs. Oudine Santos, G.R. No. 195542, 19 March 2014).
