

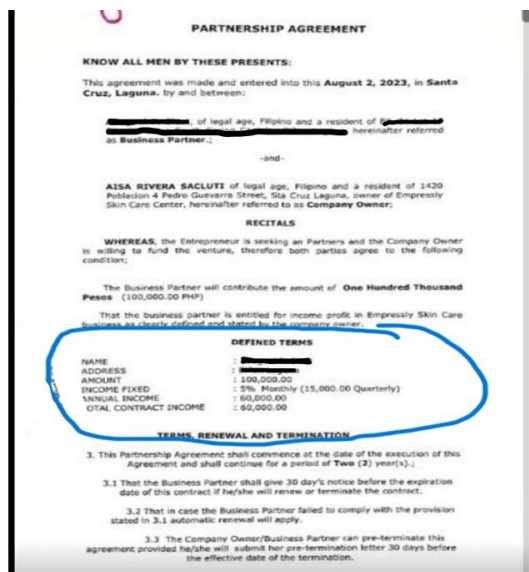


ENFORCEMENT AND INVESTOR PROTECTION DEPARTMENT

SEC ADVISORY

This Advisory is prompted by reports and information received by the Commission that individuals or group of persons representing **EMPRESSLY SKIN CARE CENTER CORP.**, is enticing the public to invest their money in the said entity with a promise of high monetary rewards or profits.

Information gathered show that **EMPRESSLY SKIN CARE CENTER CORP.**, headed by **MS. AISA RIVERA SACLUTI** entices the public to invest a minimum of Fifty Thousand Pesos (Php50,000.00) for the expansion of their clinic branches and promises to receive a return of their investment (principal) within 1-3 years with a promised of 5% guaranteed monthly interest or Php 30,000 annual income, as shown below:



Empressly is a place where beauty, comfort, knowledge and personalized attention combine to create a totally memorable rejuvenating experience.

In this regard, the public is made aware that an “*investment contract*,” which is a kind of security, exists when there is an investment or placement of money in a common enterprise with a reasonable expectation of profits to be derived from the efforts of others, which is prominent in the scheme of **EMPRESSLY SKIN CARE CENTER CORP.**

As such, the Securities Regulation Code (SRC) requires that said offer and/or sale of securities must be duly registered with the Commission and that the concerned entity and/or its agents should have the appropriate registration and/or license to sell such securities to the public.

Records of the Commission show that **EMPRESSLY SKIN CARE CENTER CORP.** is registered with the Commission on 12 December 2022 under SEC Reg. No. 2022120078486-40 as a corporation but it is **not authorized to solicit investments from the public.**

In view thereof, the public is hereby advised **NOT TO INVEST** or to **STOP INVESTING** in the investment scheme being offered by **EMPRESSLY SKIN CARE CENTER CORP.** and its **representatives.**

Moreover, **R.A. No. 11765** or the **Financial Products and Services Consumer Protection Act** (FCPA) prohibits the commission of “Investment fraud”, defined as any form of deceptive solicitation of investments from the public which includes Ponzi schemes and such other schemes involving the promise or offer of profits or returns sourced from the investments or contributions made by the investors themselves and the offering or selling of investment schemes to the public without a license or permit from the SEC.

Those who act as salesmen, brokers, dealers or agents, representatives, promoters, recruiters, uplines, influencers, endorsers, abettors and enablers of **EMPRESSLY SKIN CARE CENTER CORP.**, in soliciting or convincing people to invest in the investment scheme being offered by the said entity including soliciting investments or recruiting investors through the internet may be held criminally liable under Section 11 of the FCPA and Section 28 of the SRC which are both penalized separately with a **maximum fine of Five Million Pesos (Php5,000,000.00) or imprisonment of Twenty One (21) years or both pursuant to Section 73 of the SRC** (*SEC vs. Oudine Santos, G.R. No. 195542, 19 March 2014*).
