DECLARATION OF LOWEST CALCULATED AND RESPONSIVE BID AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2024-095)

WHEREAS, Purchase Request No. 202404217 (Annex A) was received on 3 April 2024 for the **Supply, Delivery, and Installation of Booth Display Package ("Project")** with approved budget for the contract in the amount of **Two Million Pesos (Php 2,000,000.00)**;

WHEREAS, the Invitation to Bid and the bidding documents for Project under Public Bidding No. 2024-019 was posted in PhilGEPS on 09 April 2024 for the abovementioned procurement. The same ITB was posted in SEC website and/or in conspicuous place inside the premises of SEC on same date;

WHEREAS, all the mandatory activities before the deadline to submit bids were undertaken and the deadline to submit bids was scheduled 03 May 2024, 11:00AM;

WHEREAS, on or before the deadline, the following bidders submitted bids with corresponding remarks:

WHEREAS, on 31 May 2024 and after post-qualification, the bid of **Red Root Artists and Artisans Multipurpose Cooperative** was determined to be responsive to all requirements and established to be compliant with the legal, technical and financial requirements;

NOW THEREFORE, foregoing considered, the Bids and Awards Committee **RESOLVES** the following;
