

AGREEMENT

THIS AGREEMENT made the 31st day of May 2024 between the **SECURITIES AND EXCHANGE COMMISSION** (hereinafter called "the Entity"), with office address at the SEC Headquarters, Makati Avenue, Salcedo Village, Brgy. Bel-air, Makati City, represented by its Information and Communications Technology Director Director, **OLIVER V. CHATO**, of the one part, and **IP SOLUTIONS, INC.**, with office address at Unit 502 Solare Bldg. Capri Oasis, Pasig City, Metro Manila, Philippines, represented by Authorized Representative, **JOSETH N. DULCE**, (hereinafter called "the Service Provider") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **MAINTENANCE OF SERVER EQUIPMENT WITH SUBSCRIPTION OF SOFTWARE LICENSES FOR ACTIVE DIRECTORY SERVER** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **ONE MILLION FIVE HUNDRED NINETY-EIGHT THOUSAND PESOS (P1,598,000.00)** (hereinafter called "the Contract Price").



NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - i. Philippine Bidding Documents (PBDs);
 - a. Schedule of Requirements;
 - b. Technical Specifications;
 - c. General and Special Conditions of the Contract; and
 - d. Supplemental or Bid Bulletins, if any
 - ii. Winning bidders' proposal, including the Eligibility requirements, documents and/or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's *conforme* thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise from part of the Contract.**
3. In consideration for the sum of the Contract Price or such other sums as may be ascertained, the Bidder agrees to provide the Project in accordance with his/her/its Quotation.
4. The Entity agrees to pay the above-mentioned sum in accordance with the terms of the Quotation.


