



## DECLARATION OF LOWEST CALCULATED AND RESPONSIVE BIDDERS AND RECOMMENDING AWARDS OF CONTRACTS

WHEREAS, Purchase Request No. 202406362 was received on 02 May 2024 for the SUPPLY AND DELIVERY OF VARTIOUS TOOLS AND MATERIALS FOR 16<sup>TH</sup> FLOOR RENOVATION - Phase 1 ("Project") with approved budget for the contract in the amount of Six Million Six Hundred Forty-Nine Thousand Pesos (Php 6,649,000.00);
