### DECLARATION OF LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2024-094)

**WHEREAS**, Purchase Request No. 202405343 (Annex A) was received on 15 May 2024 for the **Provision of Meals (AM Snacks and Lunch) for the SEC CAN Seminar in Davao City** with approved budget for the contract in the amount of **One Hundred Eighty Five Thousand One Hundred Sixty Six Pesos and 67/100 (Php 185,166.67)**;

**WHEREAS**, Request for Quotation No. 2024-055 was posted in PhilGEPS on 17 May 2024 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

**WHEREAS**, in compliance with Republic Act No. 9184 and its implementing rules and regulations, the Bids and Awards Committee Secretariat, on 17 May 2024, invited (Annex C is proof) the legally, technically, and financially capable suppliers;




