DECLARATION OF LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2024-094)

WHEREAS, Purchase Request No. 202405343 (Annex A) was received on 15 May 2024 for the Provision of Meals (AM Snacks and Lunch) for the SEC CAN Seminar in Davao City with approved budget for the contract in the amount of One Hundred Eighty Five Thousand One Hundred Sixty Six Pesos and 67/100 (Php 185,166.67);

WHEREAS, Request for Quotation No. 2024-055 was posted in PhilGEPS on 17 May 2024 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

WHEREAS, in compliance with Republic Act No. 9184 and its implementing rules and regulations, the Bids and Awards Committee Secretariat, on 17 May 2024, invited (Annex C is proof) the legally, technically, and financially capable suppliers;

WHEREAS, on or before the deadline to submit quotations- i.e. 23 May 2024, 05:00 PM – the following quotations were received and opened (Annex D is Abstract of Quotation):
