DECLARATION OF SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2024-089)

WHEREAS, Purchase Request No. 202403118 (Annex A) was received on 25 March 2024 for the **MAINTENANCE OF SERVER EQUIPMENT WITH SUBSCRIPTION OF SOFTWARE LICENSES FOR ACTIVE DIRECTORY SERVER ("Project")** with approved budget for the contract in the amount of **ONE MILLION SIX HUNDRED TWENTY THOUSAND PESOS (PHP1,620,000.00)**;

WHEREAS, the Invitation to Bid and the bidding documents for the Project under Public Bidding No. 2024-017 was posted in PhilGEPs on 12 April 2024 for the abovementioned procurement. The same ITB was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

WHEREAS, all the mandatory activities before the deadline to submit bids were undertaken and the deadline to submit was scheduled on 03 May 2024;

WHEREAS, on or before the deadline, only IP Solutions Inc. submitted its bid in the amount Php1,598,000.00 which was rated "passed" during the preliminary examination of bids;

WHEREAS, after the necessary bid evaluation on 03 May 2024, the bid of **IP SOLUTIONS INC.**, was determined and declared as the Single Calculated Bid, and notice was sent to the latter requiring the submission post-qualification documents;

WHEREAS, on 17 May 2024 and after post-qualification, the bid of IP SOLUTIONS INC., was determined to be responsive to all requirements and established to be compliant with all the legal, technical and financial requirements;

NOW, THEREFORE, foregoing considered, the Bids and Awards Committee **RESOLVES** the following;


1. To declare the bid of **IP SOLUTIONS INC.**, in the amount of **ONE MILLION FIVE HUNDRED NINETY-EIGHT THOUSAND PESOS (P1,598,000.00)**, all inclusive of VAT and applicable taxes, as the Single Calculated and Responsive Bid for the above-mentioned projects; and
2. To recommend to the Head of the Procuring Entity/Authorized Representative that the contract for the **MAINTENANCE OF SERVER EQUIPMENT WITH SUBSCRIPTION OF SOFTWARE LICENSES FOR ACTIVE DIRECTORY SERVER**, under Public Bidding No. 2024-017, be awarded to **IP SOLUTIONS INC.**




