

AGREEMENT

THIS AGREEMENT made this ___ day of May 2024 between the **SECURITIES AND EXCHANGE COMMISSION**, with office address at The SEC Headquarters, 7907 Makati Avenue, Salcedo Village, Bel-air, Makati City, represented herein by its ICTD Director, **OLIVER V. CHATO** (hereinafter called as "the Entity"), of the one part, and **TELNOVO COMMUNICATION, INC.**, with office address at Level 10-1 Fort Legend Tower, 30th and 3rd Avenue, BGC, Taguig City, represented herein by its President and CEO, **MIGUEL CARMELO P. MENDOZA** (hereinafter called as "the Service Provider"), of the other part;


WHEREAS, the Entity invited Quotations for the Procurement of Call Center System and Related Components ("the Project") and has accepted a Quotation by the bidder in the price of **One Million Two Hundred Seventy Five Thousand Five Hundred Ninety Pesos and 40/100 (Php 1,275,590.40)** (hereinafter called "the Contract Price").

3. In consideration for the sum of the Contract Price or such other sums as may be ascertained, the Servicing Agency agrees to provide the Project in accordance with his/her/its Proposal
4. The Entity agrees to pay the above-mentioned sum in accordance with the terms of the Proposal
