**Whereas**, the Microfinance NGO Regulatory Council (MNRC) is committed to supporting the microfinance sector through policies and regulatory measures;

**Whereas**, it is imperative to assess the effectiveness of this preferential tax rate on the financial health and operational capacities of the beneficiary MF-NGOs;

**Whereas**, data collected from such assessments will inform future policy-making and legislative initiatives aimed at further bolstering the microfinance sector;

**Whereas**, understanding the utilization patterns of the preferential tax rate and the reasons behind its usage or non-usage is crucial for enhancing the effectiveness of support mechanisms;

**Now, therefore**, the Microfinance NGO Regulatory Council invites all accredited and previously accredited MF-NGOs to participate in a comprehensive survey.

## **Objectives of the Survey:**

- 1. **Assessment**: To evaluate how the 2% preferential tax rate has affected the financial performance and operational efficiency of accredited MF-NGOs.
- 2. **Utilization Analysis**: To ascertain whether the preferential tax rate has been utilized by the MF-NGOs and to understand the reasons for its usage or non-usage.
- 3. **Informing Future Legislation**: To collect data that will assist in the formulation of future policies and legislation aimed at further supporting the microfinance sector
- 4. **Operational Insights**: To identify the benefits and challenges faced by MF-NGOs as a result of the preferential tax rate, enabling us to improve our support

mechanisms.

5. **Sectoral Development**: To gather insights that will contribute to the overall development and sustainability of the microfinance sector.
