**DECLARATION OF LOWEST CALCULATED AND RESPONSIVE QUOTATION AND  
RECOMMENDING AWARD OF CONTRACT**

(Resolution No. 2024-074)

**WHEREAS**, Purchase Request No. 202401074 (Annex A) was received on 30 January 2024 for the **Procurement of Call Center System and Related Components** with an approved budget for the contract in the amount of **ONE MILLION FOUR HUNDRED THOUSAND PESOS (P1,400, 000.00)**;

**WHEREAS**, in its Resolution No. 2024-061, the Bids and Awards Committee declared a second failure of bidding and recommended undertaking the project through Negotiated Procurement - Two Failed Biddings in accordance with Section 53.1 of the Republic Act No. 9184 and its implementing rules and regulations;

**WHEREAS**, the Request for Quotation AMP No. 2024-041 was posted in PhilGEPS on 04 April 2024 for the abovementioned negotiated procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

**WHEREAS**, in compliance with Republic Act No. 9184 and its implementing rules and regulations, the Bids and Awards Committee Secretariat, on 04 April 2024, invited (Annex C is proof) the legally, technically, and financially capable suppliers;

**WHEREAS**, on or before the deadline to submit best offers - i.e. 19 April 2024, 5:00 P.M. - offers were received from Telnovo Communications Inc., and Sophie's Information Technology Services;


**WHEREAS**, on 22 April 2024, bids were opened (Annex D is Abstract of Quotations) as follows:

**WHEREAS**, after verification and validation of the lowest calculated quotation on 30 April 2024 (Annex E is Evaluation Report), it was determined that the quotation of **Telnovo Communications, Inc.** in the amount of **One Million Two Hundred Seventy-Five Thousand Five Hundred Ninety Pesos and 40//100 (P1,275,590.40)** is the lowest calculated and responsive quotation for the subject procurement;

**NOW, THEREFORE**, we, the members of the Bids and Awards Committee, hereby resolve to declare the quotation of **TELNOVO COMMUNICATIONS, INC.** in the amount of **One Million Two Hundred Seventy-Five Thousand Five Hundred Ninety Pesos and 40//100 (P1,275,590.40)** as the Lowest Calculated and Responsive Quotation for the **Procurement of Call Center System and Related Components** and to recommend to the Head of the Procuring Entity the award of contract to the same bidder in accordance with the terms and conditions of the Request for Quotation AMP No. 2024-041 and accepted quotation.


