## DECLARATION OF LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2024-113)

WHEREAS, Purchase Request No. 202405344 (Annex A) was received on 14 June 2024 for the Engagement of a Learning Service Provider for the Conduct of the SEC Customer Centricity and Customer Relations Management with an approved budget for the contract in the amount of THREE HUNDRED NINETY THOUSAND PESOS (\$\mathbb{P}\$390,000.00);

**WHEREAS**, Request for Quotation AMP No. 2024-064 was posted in PhilGEPS on 19 June 2024 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in the Securities and Exchange Commission (SEC) website and/or in a conspicuous place inside the premises of SEC on the same date;

**WHEREAS**, in compliance with Republic Act No. 9184 and its implementing rules and regulations, the Bids and Awards Committee Secretariat, on 20 June 2024, invited (Annex C is proof) the legally, technically, and financially capable suppliers;

**WHEREAS**, on or before the deadline to submit quotations - i.e. 26 June 2024, 12:00 P.M. - the following quotations were received and opened (Annex D is Abstract of Quotations):
