

CONTRACT AGREEMENT

THIS AGREEMENT made the 5th day of July 2024 between **SECURITIES AND EXCHANGE COMMISSION** (hereinafter called "the Entity"), with office address at SEC Headquarters, Makati Avenue, Salcedo Village, Makati City, represented herein by its Director, **RACHEL ESTHER J. GUMTANG-REMALANTE**, of the one part, and **BRIQUETTOR ASSOCIATION OF THE PHILIPPINES, INC.**, herein represented by its President, **JORGE P. PASAGDAN**, with office address at 152 San Lorenzo Hilltop, Norzagaray, Bulacan, Philippines (hereinafter called "the Supplier"), of the other part;

WHEREAS, the Entity invited Quotations for certain goods and ancillary services, particularly **SUPPLY OF GOODS AND SERVICES FOR THE IMPLEMENTATION OF SEC FOREST PROJECT** ("the Project") and has accepted a Quotation by the Supplier for the supply of those goods and services in the sum of **THREE HUNDRED EIGHTY-FOUR THOUSAND FOUR HUNDRED TWENTY PESOS (P384,420.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Request for Quotation;
 - i. Schedule of Delivery;
 - ii. Technical Specifications;
 - iii. Terms and Conditions; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidders' quotation, including the Eligibility requirements, documents and/or statements submitted;
 - iii. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - iv. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of the Contract Price or such other sums as may be ascertained, the Supplier agrees to provide the Project in accordance with his/her/its Quotation.
4. The Entity agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
