DECLARATION OF SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2024-121)

WHEREAS, Purchase Request No. 202407387 (Annex A) was received on 05 July 2024 for the **Supply and Delivery of Portable Air-Conditioning Units for the Securities and Exchange Commission** with approved budget for the contract in the amount of **Seven Hundred Eighty-Eight Thousand Pesos (Php 788,000.00)**;

WHEREAS, Request for Quotation No. 2024-071 was posted in PhilGEPS on 15 July 2024 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

WHEREAS, in compliance with Republic Act No. 9184 and its implementing rules and regulations, the Bids and Awards Committee Secretariat, on 15 July 2024, invited (Annex C is proof) the legally, technically, and financially capable suppliers;

WHEREAS, on or before the deadline to submit quotations- i.e., 18 July 2024, 10AM – only the quotation from **Gridpoint Technologies Inc.** in the amount ₱705,788.00 following quotation was accepted and opened (Annex D is Abstract of Quotation);

WHEREAS, after verification and validation of all accepted proposals on 26 July 2024 (Annex E are the Evaluation Reports), it was determined that the quotation of **Gridpoint Technologies Inc.** in the amount of **SEVEN HUNDRED FIVE THOUSAND SEVEN HUNDRED EIGHTY-EIGHT PESOS (P705,788.00)** is the single calculated and responsive quotation for the subject procurement.


