### DECLARATION OF SINGLE CALCULATED AND RESPONSIVE BIDDERS AND RECOMMENDING AWARDS OF CONTRACTS

(Resolution No. 2024-129)

**WHEREAS**, Purchase Request No. 202406362 (Annex A) was received on 18 June 2024 for the **SUPPLY AND DELIVERY OF VARIOUS MATERIALS FOR 16<sup>TH</sup> FLOOR RENOVATION (Phase 2) – Lot 5: Operable Wall System (“Project”)** with approved budget for the contract in the amount of **Two Million Five Hundred Thousand Pesos (Php 2,500,000.00)**;

**WHEREAS**, the Invitation to Bid and the bidding documents for the Project under Public Bidding No. 2024-027 was posted in PhilGEPS on 19 June 2024 for the abovementioned procurement. The same IB was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

**WHEREAS**, all the mandatory activities before the deadline to submit bids were undertaken and the deadline to submit was scheduled on 10 July 2024, 11:00 AM;

**WHEREAS**, on or before the deadline, only Interworld Enterprises Inc. submitted the bid for Lot 5 in the amount of **Two Million Four Hundred Seventy-Three Thousand Five Hundred Twenty Pesos (Php 2,473,520.00)**;

**WHEREAS**, after the necessary bid evaluation on 12 July 2024 (Annex B is the report), the bid of Interworld Enterprises Inc. was determined and declared as the Single Calculated Bid and notice was sent requiring its submission of post-qualification documents;

**WHEREAS**, on 14 August 2024 and after post-qualification, the bid of Interworld Enterprises Inc. was determined to be responsive to all requirements and was established to be compliant with all the legal, technical and financial requirements;

**NOW, THEREFORE**, foregoing considered, the Bids and Awards Committee **RESOLVES** the following;

1. To declare the bids of **Interworld Enterprises Inc.** in the amount of **TWO MILLION FOUR HUNDRED SEVENTY-THREE THOUSAND FIVE HUNDRED TWENTY PESOS (Php 2,473,520.00)**, inclusive of VAT and applicable taxes, as the Single Calculated and Responsive Bid for the above-mentioned project;
2. To recommend to the Head of the Procuring Entity/Authorized Representative that the contract for the **SUPPLY AND DELIVERY OF VARIOUS MATERIALS FOR 16<sup>TH</sup> FLOOR RENOVATION (Phase 2) - Lot 5: Operable Wall System**, under Public Bidding No. 2024-027, be awarded to the above-mentioned bidder.
