DECLARATION OF SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, Purchase Request No. 202405352 (Annex A) was received on 05 June 2024 for the **Support and Maintenance Services for the Existing Customized Microsoft Project** with approved budget for the contract in the amount of **Five Hundred Sixty Thousand Pesos (Php 560,000.00)**;


