DECLARATION OF LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2024-131)

WHEREAS, Purchase Request No. 202407402 (Annex A) was received on 31 July 2024 for the Supply, Delivery, and Installation of Office Modular Workstation, Office Furniture, Fit-outs for the SEC Butuan Extension Office with approved budget for the contract in the amount of Nine Hundred Ninety-Eight Thousand Two Hundred Pesos (Php998,200.00);

WHEREAS, Request for Quotation AMP No. 2024-075 was posted in PhilGEPS on 10 August 2024 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

WHEREAS, in compliance with Republic Act No. 9184 and its implementing rules and regulations, the Bids and Awards Committee Secretariat, on 12 August 2024, invited (Annex C is proof) the legally, technically, and financially capable suppliers/contractors;

WHEREAS, on or before the deadline to submit quotation/s, 16 August 2024, 10:00 AM – the below quotations were received and opened (Annex D is Abstract of Quotation):

WHEREAS, after verification and validation of the proposal on 21 August 2024 (Annex E is Evaluation Report), it was determined that the quotation of **Milouch Enterprises** in the amount of **Nine Hundred Fifty-Seven Thousand Seven Hundred Eighty-Seven Pesos and 50/100 (P957,787.50)** is the lowest calculated and responsive quotation for the subject procurement.
