(Resolution No. 2024-133)

WHEREAS, Purchase Request No. 202405350 (Annex A) was received on 09 May 2024 for the **SUPPLY AND DELIVERY OF FOUR (4) BRAND NEW SERVICE VEHICLES FOR THE SECURITIES AND EXCHANGE COMMISSION HEADQUARTERS – REBIDDING (“Project”)**, with approved budget for the contract in the amount of **FOUR MILLION EIGHT HUNDRED THOUSAND PESOS (PHP4,800,000.00)**;
