

AGREEMENT

THIS AGREEMENT made this 12th day of September 2024 between the **SECURITIES AND EXCHANGE COMMISSION** (hereinafter called "the Entity"), with office address at The SEC Headquarters, 7907 Makati Avenue, Salcedo Village, Bel-air, Makati City, represented herein by **RICKY M. ABUNDO**, the Officer-in-Charge of the Human Resource Department, of the one part, and **EAST SHERPA MANAGEMENT TRAINING AND CONSULTING SERVICES**, represented herein by **AL MARCIAL C. BENGCO**, the proprietor, with office address at #91 Richard St., Kings Ville Subdivision, Mayamot, Antipolo City (hereinafter called "the Consultant"), of the other part;

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - (a) Terms of Reference;
 - (b) Request for Quotation;
 - (c) The Winning Bidder's quotation, including the Eligibility requirements, documents and/or statements submitted;
 - (d) Notice of Award of Contract and the Service Provider's conforme thereto; and
 - (e) Other contract documents that may be required by existing laws and/or the Entity
3. In consideration for the sum of the Contract Price or such other sums as may be ascertained, the Servicing Agency agrees to provide the Project in accordance with his/her/its Proposal
4. The Entity agrees to pay the above-mentioned sum in accordance with the terms of the Proposal
