DECLARATION OF LOWEST CALCULATED AND RESPONSIVE BID AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2024-132)

WHEREAS, Purchase Request No. 202407398 (Annex A) was received on 23 July 2024 for the SUPPLY AND DELIVERY OF VARIOUS TONERS FOR THE SECURITIES AND EXCHANGE COMMISSION with approved budget for the contract in the amount of TWO MILLION TWO HUNDRED FIFTY-EIGHT THOUSAND PESOS (PHP2,258,000.00);

WHEREAS, the Invitation to Bid and the bidding documents SUPPLY AND DELIVERY OF VARIOUS TONERS FOR THE SECURITIES AND EXCHANGE COMMISSION, under Public Bidding No. 2024-029 was posted in PhilGEPS on 29 July 2024. The same ITB was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

WHEREAS, all the mandatory activities before the deadline to submit bids were undertaken and the deadline to submit was scheduled on 19 August 2024, 10:00 AM;

WHEREAS, on or before the deadline, the following bidders submitted their bids with corresponding remarks/rating;

NOW, THEREFORE, foregoing considered, the Bids and Awards Committee **RESOLVES** the following;

- To declare the bid of QUARTZ BUSINESS PRODUCTS CORP. in the amount of ONE MILLION FIVE HUNDRED FIFTY-EIGHT THOUSAND FIVE HUNDRED FIVE PESOS (Php 1,558,505.00), all inclusive of VAT and applicable taxes, as the Lowest Calculated and Responsive Bid for the above-mentioned projects; and
