**DECLARATION OF LOWEST CALCULATED AND RESPONSIVE BIDDER AND
RECOMMENDING AWARD OF CONTRACT**

(Resolution No. 2024-152)

WHEREAS, Purchase Request No. 202408411 (Annex A) was received on 05 August 2024 for the **SUPPLY, DELIVERY, INSTALLATION, AND CONFIGURATION OF INTERACTIVE WHITEBOARD/SMARTBOARD, ("Project")** with approved budget for the contract in the amount of **Eleven Million Fifty-Seven Thousand Pesos (Php 11,057,000.00)**;

WHEREAS, the Invitation to Bid and the bidding documents for the Project under Public Bidding No. 2024-033 was posted in PhilGEPS on 09 August 2024 for the abovementioned procurement. The same IB was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

WHEREAS, all the mandatory activities before the deadline to submit bids were undertaken and the deadline to submit was scheduled on 06 September 2024, 10:00 AM;

WHEREAS, on or before the deadline, the following bidders submitted their bids with the corresponding remarks;

WHEREAS, after the necessary bid evaluation on 09 September 2024 the bid of American Technologies Inc., was determined and declared as the Lowest Calculated Bid, and notice was sent to the latter requiring the submission of post-qualification documents;

WHEREAS, on 13 September 2024 and after post-qualification, it has been determined that based on the technical specifications and datasheet submitted by American Technologies Inc., it is **NOT COMPLIANT** with the minimum technical requirements of the project;

WHEREAS, pursuant to Section 34.3.b of the 2016 revised implementing rules and regulation of RA No.9184, American Technologies Inc., was declared post-disqualified and the corresponding Notice was issued on 16 September 2024;

WHEREAS, on 23 September 2024 and after post-qualification evaluation on the bid of the second lowest bidder, Cosmotech Philippines, Inc., was determined to be responsive to all requirements and was established to be compliant with all the legal, technical and financial requirements;

NOW, THEREFORE, foregoing considered, the Bids and Awards Committee **RESOLVES** the following;

1. To declare the bid of **Cosmotech Philippine, Inc.**, in the amount of **FIVE MILLION SIX HUNDRED FORTY THOUSAND PESOS (Php 5,640,000.00)**, inclusive of VAT and



applicable taxes, as the Lowest Calculated and Responsive Bid for the above-mentioned project;

2. To recommend to the Head of the Procuring Entity/Authorized Representative that the contract for the **SUPPLY, DELIVERY, INSTALLATION, AND CONFIGURATION OF INTERACTIVE WHITEBOARD/SMARTBOARD**, under Public Bidding No. 2024-033, be awarded to the above-mentioned bidder.


