### **DECLARATION OF SINGLE CALCULATED AND RESPONSIVE BID AND RECOMMENDING AWARD OF CONTRACT**

(Resolution No. 2024-134)

**WHEREAS**, Purchase Request No. 202403201 was received on 23 July 2024 for the **SUBSCRIPTION TO FORTINET FIREWALL FOR HEAD OFFICE SEC CO-LOCATION AND EXTENSION OFFICES WITH FORTIANALYZER ("Project")** with approved budget for the contract in the amount of **TWO MILLION NINE HUNDRED SEVENTY THOUSAND FOUR HUNDRED SIXTY-ONE PESOS (Php2,970,461.00)**;

**WHEREAS**, the Invitation to Bid and the bidding documents for the Project under Public Bidding No. 2024-031 was posted in PhilGEPS on 29 July 2024 for the abovementioned procurement. The same ITB was posted in SEC website and/or in conspicuous place inside the premises of SEC on same date;

**WHEREAS**, all the mandatory activities before the deadline to submit bids were undertaken and the deadline to submit bids was scheduled on 19 August 2024, 2:30PM;

**WHEREAS**, on or before the deadline, only *Infobahn Communications, Inc.* submitted its bid in the amount of **₱2,968,952.00** which received the remarks "*passed*" after the conduct of preliminary examination of bids;

**WHEREAS**, the necessary bid evaluation on 19 August 2024, the bid of Infobahn Communications, Inc. was determined and declared as the Single Calculated Bid, and notice was sent to the latter requiring the submission post-qualification documents;

**WHEREAS**, on 27 August 2024 and after post-qualification, the bid of Infobahn Communications, Inc. was determined to be responsive to all requirements and established to be compliant with all the legal, technical and financial requirements;

**NOW THEREFORE**, foregoing considered, the Bids and Awards Committee **RESOLVES** the following;

1. to declare the bid of Infobahn Communications, Inc. in the amount of **TWO MILLION NINE HUNDRED SIXTY-EIGHT THOUSAND NINE HUNDRED FIFTY-TWO PESOS (Php2,968,952.00)**, inclusive of VAT and applicable taxes, as the Single Calculated and Responsive Bid for the above-mentioned project; and
2. to recommend to the Head of the Procuring Entity/Authorized Representative that the contract for the **SUBSCRIPTION TO FORTINET FIREWALL FOR HEAD OFFICE SEC CO-LOCATION AND EXTENSION OFFICES WITH FORTIANALYZER** under Public Bidding No. 2024-031 be awarded to **INFOBAHN COMMUNICATIONS, INC.**
