



BIDS AND AWARDS COMMITTEE

RECOMMENDING APPROVAL OF SINGLE RATED BID AND THE CONDUCT OF NEGOTIATION AND SUCCEEDING ACTIVITIES

(Resolution No. 2024-162)

WHEREAS, the Securities and Exchange Commission (SEC) through its Bids and Awards Committee (BAC), posted the Request for Expression of Interest for the procurement for the **PROCUREMENT OF CONSULTING SERVICES FOR THE CAMPAIGN, DEVELOPMENT, MANAGEMENT, AND IMPLEMENTATION OF INVESTOR PROTECTION WEEK 2024 ("Project")** on 22 August 2024, with an Approved Budget for the Contract in the amount of **Ten Million Pesos (P10,000,000.00)**;

WHEREAS, in its Resolution No. 2024-138 dated 05 September 2024, the BAC recommended and the Head of the Procuring Entity/Authorized Representative approved the shortlist of consultant/s, with only Marcus Phoenix Media Production Corp. as the shortlisted with the eligibility rating of 70.50;

WHEREAS, on 05 September 2024, the shortlisted consultant was notified and the bidding documents and forms for the Part II were posted on PhilGEPS and SEC website, as well as the conspicuous places in the SEC premises;

WHEREAS, before the deadline for submission on 27 September 2024 at 1:00 P.M., the shortlisted consultant acquired and paid for the bidding documents, and submitted its bids, to wit:

WHEREAS, on the same date, the BAC, using the non-discretionary pass-fail criterion, conducted the preliminary examination of the bids and found that the technical proposals submitted were "**compliant**" with the requirements;

WHEREAS, based on the Technical Evaluation Report submitted to the BAC, the shortlisted bidder Marcus Phoenix Media Production Corp. received the rating 70.17;

WHEREAS, during the opening of Financial Proposals on 02 October 2024, the proposed price of Marcus Phoenix Media Production Corp. in the amount of P10,000,000.00 (inclusive of taxes) was shown and recorded;

WHEREAS, the BAC, through the TWG, conducted Quality-Cost Based Evaluation (QCBE) on the proposals of Marcus Phoenix Media Production Corp., which resulted to 85.17% rating;

NOW, THEREFORE, on the basis of the foregoing, the Bids and Awards Committee **RESOLVES** the following:


1. To declare **MARCUS PHOENIX MEDIA PRODUCTION CORP.** as the **Single Rated Bid** for the **PROCUREMENT OF CONSULTING SERVICES FOR THE CAMPAIGN, DEVELOPMENT, MANAGEMENT, AND IMPLEMENTATION FOR INVESTOR PROTECTION WEEK 2024**; and

2. To recommend to the Head of Procuring Entity to authorize the Bids and Awards Committee to negotiate with Marcus Phoenix Media Production Corp.
