DECLARATION OF LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2024-159)

WHEREAS, Purchase Request No. 202409455 (Annex A) was received on 18 September 2024 for the **Supply and Delivery of Shirts for the Conduct of Commission-Wide Supervision 2028 Performance Review and Internal Targets (SPRINT) Updating Conference** with approved budget for the contract in the amount of **Three Hundred Thirty-Six Thousand Fifty Pesos (Php336,050.00)**;

WHEREAS, Request for Quotation No. 2024-090 was posted in PhilGEPS on 20 September 2024 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

WHEREAS, in compliance with Republic Act No. 9184 and its implementing rules and regulations, the Bids and Awards Committee Secretariat, on 20 September 2024, invited (Annex C is proof) the legally, technically, and financially capable suppliers;

WHEREAS, on or before the deadline to submit quotations – i.e. 25 September 2024, 10:00AM – the following quotations were received and opened (Annex D is Abstract of Quotation):


WHEREAS, in its Resolution No. 2024-153, the Bids and Awards Committee recommended the award of contract to Knit & Tuck Merchandising in the amount of Two Hundred Twenty-Seven Thousand Five Hundred Pesos (₱227,500.00) and the corresponding Notice of Award was issued on 01 October 2024;


WHEREAS, on 02 October 2024, Knit & Tuck Merchandising refused to enter into a contract (Annex E is the Letter);

WHEREAS, after verification and validation of the received quotation from the second lowest calculated quotation on 02 October 2024 (Annex E is Evaluation Report), it was determined that the quotation of **Work Habits Trading** in the amount of **Two Hundred Thirty-Two Thousand Seven Hundred Pesos (₱232,700.00)** is the lowest calculated and responsive quotation for the subject procurement.

NOW, THEREFORE, we, the members of the Bids and Awards Committee, hereby resolve to declare the quotation of **Work Habits Trading** in the amount of **Two Hundred Thirty-Two Thousand Seven Hundred Pesos (₱232,700.00)** as the lowest calculated and responsive quotation for the **Supply and Delivery of Shirts for the Conduct of Commission-Wide Supervision 2028 Performance Review and Internal Targets (SPRINT) Updating Conference**, and to recommend to the Head of the Procuring Entity/Authorized Representative the award of contract to the same bidder in accordance with the terms and conditions of the Request for Quotation No. AMP 2024-090 and accepted quotation.
