**DECLARATION OF HIGHEST RATED AND RESPONSIVE QUOTATION
AND RECOMMENDING AWARD OF CONTRACT**

(Resolution No. 2024-150)

WHEREAS, Purchase Request No. 202408437 (Annex A) was received on 23 August 2024 for the **ENGAGEMENT OF LEARNING SERVICE PROVIDER FOR THE HIGHER-ORDER OF THINKING TRAINING PROGRAM**, with an approved budget for the contract in the amount of **NINE HUNDRED THOUSAND PESOS (P900,000.00)**;

WHEREAS, Request for Quotation AMP No. 2024-084 was posted in PhilGEPS on 27 August 2024 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in the Securities and Exchange Commission (SEC) website and/or in a conspicuous place inside the premises of SEC on the same date;

WHEREAS, in compliance with Republic Act No. 9184 and its implementing rules and regulations, the Bids and Awards Committee Secretariat, on 02 September 2024, invited (Annex C is proof) the legally, technically, and financially capable suppliers;

WHEREAS, on or before the deadline to submit quotations - i.e. 09 September 2024, 10:00 A.M. - the following quotations were received and opened (Annex D is Abstract of Quotations):

WHEREAS, in accordance with Section 33.2.1.2 of the above-cited law and as specified in the request for quotation, quality-cost-based evaluation procedure was used in evaluating the submitted quotations/proposals;

WHEREAS, on 11 September 2024 and after quality-cost-based evaluation, the above quotations/proposals received the corresponding ratings:

WHEREAS, with the minimum required score of 80 points, only People Dynamics, Inc. was declared qualified with a score of 85.14%;


WHEREAS, on 18 September 2024, after the Quality Cost-Based Evaluation, verification, and validation of accepted proposals (Annex E), it was determined that the quotation of **People Dynamics, Inc.**, in the amount of **Nine Hundred Thousand Pesos (P900,000.00)** is the highest rated and responsive quotation for the subject procurement.
