## DECLARATION OF SINGLE CALCULATED AND RESPONSIVE BID AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2024-139)

WHEREAS, Purchase Request No. 20206367 (Annex A) was received on 16 July 2024 for the Supply and Delivery of Specialty Paper ("Project") with approved budget for the contract in the amount of One Million Seven Hundred Sixty Thousand Pesos (Php 1,760,000.00);

**WHEREAS**, the Invitation to Bid and the bidding documents for the Project under Public Bidding No. 2024-030 was posted in PhilGEPS on 27 July 2024. The same ITB was posted in SEC website and/or in conspicuous place inside the premises of SEC on same date;

**WHEREAS**, all the mandatory activities before the deadline to submit bids were undertaken and the deadline to submit bids was scheduled 19 August 2024, 11:00AM;

**WHEREAS**, on or before the deadline, only Multi-Forms Corporation submitted its bid in the amount **P1,464,800.00** which received the remarks "passed" after the conduct of preliminary examination of bids;

**WHEREAS**, after the necessary bid evaluation on 19 August 2024 the bid of *Multi-Forms Corporation* was determined and declared as the Single Calculated Bid, and notice was sent to the latter requiring the submission of post-qualification documents;

**WHEREAS,** on 05 September 2024 and after post-qualification, the bid of *Multi-Forms Corporation* was determined to be responsive to all requirements and established to be compliant with all the legal, technical, and financial requirements;

**NOW THEREFORE,** foregoing considered, the Bids and Awards Committee **RESOLVES** the following;

- to declare the bid of Multi-Forms Corporation in the amount of ONE MILLION FOUR HUNDRED SIXTY-FOUR THOUSAND EIGHT HUNDRED PESOS (P1,464,800.00), inclusive of VAT and applicable taxes, as the Single Calculated and Responsive Bid for the above-mentioned project; and
- to recommend to the Head of the Procuring Entity/Authorized Representative that the contract for the SUPPLY AND DELIVERY OF SPECIALTY PAPER under Public Bidding No. 2024-030 be awarded to MULTI-FORMS CORPORATION.
