DECLARATION OF HIGHEST RATED AND RESPONSIVE BID AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2024-183)

WHEREAS, Purchase Request No. 202401033 was received on 04 April 2024 for the **SUPPLY, DELIVERY, INSTALLATION, CONFIGURATION, AND IMPLEMENTATION OF THE FULLY FUNCTIONAL DOCUMENT MANAGEMENT SYSTEM, AND WORKFLOW MANAGEMENT SYSTEM FOR THE SECURITIES AND EXCHANGE COMMISSION (SEC) ("Project")** with approved budget for the contract in the amount of **ONE HUNDRED SEVENTY MILLION PESOS (Php 170,000,000.00)**;

WHEREAS, the Request for Expression of Interest for the Project was posted on 15 April 2024 in PhilGEPS, in Securities and Exchange Commission's (SEC) website, and/or in conspicuous place inside the premises of SEC;

WHEREAS, on 22 May 2024, a Notice of Cancellation was issued by the Head of the Procuring Entity due to the necessity to update and revise the terms of reference for the benefit of the SEC and the government as a whole;

WHEREAS, for its rebidding, the Request for Expression of Interest for the Project was reposted on 11 June 2024 in PhilGEPS, in Securities and Exchange Commission's (SEC) website, and/or in conspicuous place inside the premises of SEC;

WHEREAS, on 18 June 2024, an initial meeting was conducted which was attended by the prospective consultants;

WHEREAS, on or before the deadline to submit eligibility documents on 26 June 2024, 2:00PM, the following prospective consultants submitted their eligibility documents, which received the following remarks/rating during the eligibility checking:

WHEREAS, in Resolution No. 2024-115 dated 16 July 2024, the Head of the Procuring Entity/Authorized Representative (HOPE) approved Bids and Awards Committee (BAC)'s recommendation to include the following in the shortlist of consultant/s;

1. Infoshare Management Services
2. Micro-D International Inc., and Remax International Inc. (Joint Venture)
3. Comclark Network & Technology Corp. and Fortis Technologies Corp. (Joint Venture)

WHEREAS, a Pre-Bid Conference was conducted on 26 July 2024, which was attended by the shortlisted bidders;

WHEREAS, before the deadline for submission on 09 August 2024, the following consultants submitted their bids which received the corresponding remarks/ratings upon the conduct of quality-cost based evaluation (QCBE):

WHEREAS, in Resolution No. 2024-137 dated 30 August 2024, Comclark Network & Technology Corp. and Fortis Technologies, Inc. (Joint Venture) was declared as the Highest Rated Bid (HRB) and the BAC was authorized by the HOPE to negotiate with the consultant;

WHEREAS, on 09 September 2024, a negotiation with Comclark Network & Technology Corp. and Fortis Technologies, Inc. (Joint Venture) was successfully conducted;


WHEREAS, on 11 September 2024 and after post-qualification, the bid of Comclark Network & Technology Corp. and Fortis Technologies, Inc. (Joint Venture) was determined to be responsive to all requirements and established to be compliant with all the legal, technical and financial requirements;

NOW THEREFORE, foregoing considered, the Bids and Awards Committee **RESOLVES** the following;

1. to declare the bid of Comclark Network & Technology Corp. and Fortis Technologies, Inc. (Joint Venture), in the amount of **ONE HUNDRED SIXTY-FIVE MILLION PESOS (Php165,000,000.00)**, inclusive of VAT and applicable taxes, as the Highest Rated and Responsive Bid for the above-mentioned project; and
2. to recommend to the Head of the Procuring Entity that the contract for the **SUPPLY, DELIVERY, INSTALLATION, CONFIGURATION, AND IMPLEMENTATION OF THE FULLY FUNCTIONAL DOCUMENT MANAGEMENT SYSTEM, AND WORKFLOW MANAGEMENT SYSTEM FOR THE SECURITIES AND EXCHANGE COMMISSION (SEC) – Rebidding**, under Public Bidding No. 2024-25, be awarded to Comclark Network & Technology Corp. and Fortis Technologies, Inc. (Joint Venture).
