**DECLARATION OF SINGLE CALCULATED AND RESPONSIVE QUOTATION AND
RECOMMENDING AWARD OF CONTRACT**

(Resolution No. 2024-163)

WHEREAS, Purchase Request No. 202409454 (Annex A) was received on 18 September 2024 for the **Supply and Delivery of Frosted Stickers** with approved budget for the contract in the amount of **Forty-Nine Thousand One Hundred Twenty-Nine Pesos (Php 49,129.00)**;

WHEREAS, Request for Quotation (AMP No. 2024-092) for the abovementioned procurement (Annex B is proof) was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;
