DECLARATION OF LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2024-146)

WHEREAS, Purchase Request No. 202408426 (Annex A) was received on 20 August 2024 for the **Supply and Delivery of SEC Logo Pin and Philippine Flag Pin** with approved budget for the contract in the amount of **Two Hundred Thousand Pesos (Php 200,000.00)**;

WHEREAS, Request for Quotation No. 2024-078 was posted in PhilGEPS on 22 August 2024 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

WHEREAS, in compliance with Republic Act No. 9184 and its implementing rules and regulations, the Bids and Awards Committee Secretariat, on 22 August 2024, invited (Annex C is proof) the legally, technically, and financially capable suppliers/contractors;

WHEREAS, on or before the deadline to submit quotations- i.e., 29 August 2024, 10:00AM – the following quotations were received and opened (Annex D is Abstract of Quotation):


