### DECLARATION OF SINGLE CALCULATED AND RESPONSIVE BID AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2024-148)

**WHEREAS**, Purchase Request No. 202403203 was received on 15 August 2024 for the **SUBSCRIPTION TO ANTI-VIRUS ("Project")** with approved budget for the contract in the amount of **ONE MILLION TWO HUNDRED NINETY-SIX THOUSAND PESOS (Php1,296,000.00)**;

**WHEREAS**, the Invitation to Bid and the bidding documents for the Project under Public Bidding No. 2024-034 was posted in PhilGEPS on 21 August 2024 for the abovementioned procurement. The same ITB was posted in SEC website and/or in conspicuous place inside the premises of SEC on same date;

**WHEREAS**, all the mandatory activities before the deadline to submit bids were undertaken and the deadline to submit bids was scheduled on 13 September 2024, 10:00AM;

**WHEREAS**, on or before the deadline, only *Infobahn Communications, Inc.* submitted its bid in the amount of **P1,294,888.00** which received the remarks "*passed*" after the conduct of preliminary examination of bids;

**WHEREAS**, the necessary bid evaluation on 13 September 2024, the bid of Infobahn Communications, Inc. was determined and declared as the Single Calculated Bid, and notice was sent to the latter requiring the submission post-qualification documents;

**WHEREAS**, on 18 September 2024 and after post-qualification, the bid of Infobahn Communications, Inc. was determined to be responsive to all requirements and established to be compliant with all the legal, technical and financial requirements;

**NOW THEREFORE**, foregoing considered, the Bids and Awards Committee **RESOLVES** the following;

1. to declare the bid of Infobahn Communications, Inc. in the amount of **ONE MILLION TWO HUNDRED NINETY-FOUR THOUSAND EIGHT HUNDRED EIGHTY-EIGHT PESOS (Php1,294,888.00)**, inclusive of VAT and applicable taxes, as the Single Calculated and Responsive Bid for the above-mentioned project; and
2. to recommend to the Head of the Procuring Entity/Authorized Representative that the contract for the **SUBSCRIPTION TO ANTI-VIRUS** under Public Bidding No. 2024-034 be awarded to **INFOBAHN COMMUNICATIONS, INC.**




