DECLARATION OF LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2024-157)

WHEREAS, Purchase Request No. 202409445 (Annex A) was received on 11 September 2024 for the SUPPLY AND DELIVERY OF FURNITURE AND EQUIPMENT AT THE SECURITIES AND EXCHANGE COMMISSION with approved budget for the contract in the amount of NINE HUNDRED FIFTY THOUSAND PESOS (Php 950,000.00);
