INVITATION TO BID

Supply, Delivery and Installation of Electrical, Civil/Architectural, and Various Requirements for SEC Office Space in PICC (re-bidding)

The **Securities and Exchange Commission (SEC)** through the General Appropriations Act for FY 2015 (Continuing Budget) intends to apply the sum of **Eleven Million Forty Nine Thousand One Hundred Sixty Pesos (Php 11,049,160.00)** being the Approved Budget for the Contract (ABC) in payment for the **Supply, Delivery and Installation of Electrical, Civil/Architectural, and Various Requirements for SEC Office Space in PICC (re-bidding)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The SEC now invites bids for the **Furnishing of all Labor, Materials, Equipment, Tools and Other Incidentals for the Supply, Delivery and Installation of Electrical, Civil/Architectural, and Various Requirements for SEC Office Space in PICC**. Completion of the Works is required within **Sixty (60) Calendar Days**. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from SEC located at SEC Building, EDSA, Greenhills, Mandaluyong City and inspect the Bidding Documents during office hours from 8:00 a.m. to 5:00 p.m.

A complete set of Bidding Documents may be acquired by Interested Bidders starting July 20, 2016 from our Procurement Division of Human Resource and Administrative Department, 4th Floor, SEC Building, EDSA Greenhills, Mandaluyong City, upon payment of a non-refundable fee of Five Thousand Pesos (Php 5,000.00), pursuant to the latest Guidelines issued by the Government Procurement Policy Board (GPPB). A bidder who acquired the Bidding Documents for a fee on the previous bidding which failed shall pay a minimal amount of Five Hundred Pesos (Php500.00) only.

Except for the Drawings and Designs, the Bidding Documents may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.
