

What could be the ensuing penalty for violation in relation to item 3 of the Omnibus Sworn Statement stating that “ it is not blacklisted or barred from bidding by the Government of the Philippines or any of its agencies..xxx” if found misrepresented by the affiant.</p>	<p>1. In case of misrepresentation by any bidder in any of the projects of the SEC, the penalty of automatic blacklisting for two (2) years in all government procurement activities shall be imposed.</p>




