The bid security shall be limited to a Bid Securing Declaration or any of the following forms and amounts: 1. The amount of not less than Php26,000.00 (2% of ABC), if bid security is in cash, cashier's/manager's check, bank draft/guarantee or irrevocable letter of credit; or 2. The amount of not less than Php169,000.00 (5% of ABC), if bid security is in Surety Bond. Bid Data Sheet (Clause 25.1)	The bid security shall be limited to a Bid Securing Declaration or any of the following forms and amounts: 1. The amount of not less than Php262,000.00 (2% of ABC), if bid security is in cash, cashier's/manager's check, bank draft/guarantee or irrevocable letter of credit; or 2. The amount of not less than Php655,000.00 (5% of ABC), if bid security is in Surety Bond. Bid Data Sheet (Clause 25.1)
b) The financial and technical proposals shall be given corresponding weights with the financial proposal given a minimum weight of fifteen percent (15%) up to a maximum of forty percent (40%). The weight of the technical criteria shall be adjusted accordingly such that their total weight in percent together with the weight given to the financial proposal shall add to one hundred percent (100%). The BAC shall rank the consultants in descending order based on the combined numerical ratings of their technical and financial proposals and identify the Highest Rated Bid.	b) The financial and technical proposals shall be given 15% and 85% weights, respectively. The BAC shall rank the consultants in descending order based on the combined numerical ratings of their technical and financial proposals and identify the Highest Rated Bid.

- Plan of approach or methodology with emphasis on the clarity, feasibility, innovativeness and comprehensiveness of the support services that will be provided by the Consultant as listed in the Terms of Reference (20 points).

The minimum points required to pass in 70/100 points.
