	<ul> <li>a) When provided for under any Treaty or International or Executive Agreement as provided in Section 4 of the Act and this IRR;</li> <li>b) When the foreign supplier is a citizen, corporation or association of a country, the laws or regulations of which grant reciprocal rights or privileges to citizens, corporations or associations of the Philippines;</li> <li>c) When the goods sought to be procured are not available from local suppliers; or</li> <li>d) When there is a need to prevent situations that defeat competition or restrain trade.</li> </ul>
	Foreign consultants may be eligible to participate in this Project, subject to the following conditions to be complied within ten (10) days upon receipt of the Notice of Award:
	<ul> <li>a) must be registered with the SEC and/or any agency authorized by the laws of the Philippines;</li> <li>b) when the types and fields of consulting services in which the foreign consultant</li> </ul>

wishes to engage involve the practice of regulated professions, the foreign consultant must be authorized by the appropriate GoP professional regulatory body specified in Clause 1.2 to engage in the practice of those professions and allied professions: *Provided, however,* That the limits of such authority shall be strictly observed.
