	Answer : According to the End-user Representative, said document will not be acceptable as proof of compliance. An actual demonstration during the post-qualification evaluation will be conducted to determine and ascertain the bidder's compliance.
	Question : Should all the machines to be used in the project be brand-new?
	Answer: Yes, all the machines should be brand-new.
€	Question : What is the responsibility of the Technical Support?
	Answer: The technical support will be responsible for the Installation and Testing of Printers.
	Question : What is the preferred software for the printer's support?
	Answer: Windows software only.
